1. RENEWAL OF ENLISTMENT OF CIVIL CONTRACTORS.

To consider and approve the process of renewal of registration of enlisted contractors with Cantonment Board :-

- Process:-
- 1) Contractor will have to pay Rs.5000/- as renewal fee .
 - 2) He should submit certificate that he is not blacklisted by any authority (proforma should be made available in office and website).

After payment , CEO wil issue fresh certificate of registration with a validity upto 31.03.2017 within 10 days of payment.

2. CLOSURE OF ROADS IN CANTONMENTS

Directorate, DE, WC, Chandigarh letter No.16/12/Amritsar/Cantt/WC/DE dated 21.03.2016 had asked to take the action afresh on this subject. In view of security requirement, Station HQ, in its letter dated 20.01.2015 requested Board to initiate action for closure of roads in following cases:-

1. Harkirat Road
2. Mohindra Road
3. Hospital Road

According to provisions of section 258 (2) of Cantonmmt Act which are produced below:-

"258 (2) A Board shall not shall not permanently close any street without the prior permission of the General Office Commanding-in-Chief , or the Principal Director.

Provided that no such street shall be closed for reasons other than the security reasons and without giving a public notice inviting objections and suggestions from the general public."
