

**CALLING QUOTATIONS FROM ELIGIBLE VENDORS FOR SUPPLY OF UNIFORM
FOR SCHOOL CHILDREN**

Quotations are hereby called from eligible bidders for supply of uniform for school children of Cantonment Board School, Amritsar Cantt. The bids can be submitted in the office of Cantonment Board Amritsar between 10.07.2020 to 31.07.2020 between working hours. The format for submission of price bid is enclosed with this notice. The eligibility documents as mentioned in the eligibility criteria shall be submitted along with the bid by the interested parties.

TERMS AND CONDITIONS

- I) Cost of quotation fee shall be free of cost. Please note that price bid will be accepted only in respect of qualified and eligible agencies who fulfill the eligibility/criteria according to their submitted application.
- II) Submission of bid does not constitute any guarantee for opening of price bid of bidder. Opening of price-bid will be decided by the Accepting Authority based on inter alia past track record, financial position, quality of the product & work experience of the agencies. No bid received after the due date shall be accepted by the Cantonment Board Amritsar.
- III) The Cantonment Board Amritsar/CEO reserves all the rights to cancel the quotation at any time or not accept the bids of the bidders without assigning any reasons thereof.
- IV) Any change/modification in the quotation enquiry will be intimated & updated through the website www.cbamritsar.org.in only. Agencies are therefore instructed to visit our website regularly to keep themselves updated.
- V) Any clarification, if needed, may be enquired from the office of Amritsar Cantonment Board as mentioned in the critical dates during office working hours only.
- VI) No conditional quotations will be accepted.
- VII) The Agencies are bound by all rules and regulations and terms and conditions as fixed by the Cantonment Board Amritsar.
- VIII) Cantonment Board Amritsar reserves to itself the right to reject conditional quotations without assigning any reasons thereof.
- IX) Cantonment Board Amritsar reserves to itself the right to reject any or all the quotations without assigning any reason thereof and to call for any other details or information from any of the quotations(s)
- X) Cantonment Board Amritsar is not responsible for any postal delay or delay due to link failure/internet problem etc. in respect of submission/receipt of any documents.
- XI) The bidders offering the lowest bid are to supply the goods according to supply order issued by this office time to time as and when required.
- XII) That the contractor shall supply the goods ordered to Cantonment Board within the time allowed by the Chief Executive Officer, Amritsar Cantt strictly in accordance with the specification mentioned in the supply order.
- XIII) That the Cantonment Board, Amritsar Cantt shall pay to the contractor only for the articles supplied.

- XIV) Only in case of unavoidable delay or genuine problem on application of contractor ten days in advance to the Chief Executive Officer who can give extension for supplying the goods, as deemed fit.
- XV) That the rejected articles, if any, shall be removed by the contractor for replacement within the time allowed by the Chief Executive Officer, Amritsar Cantt.
- XVI) That if it is detected that any over payment has been made to the contractor under this contract such over payment shall be recoverable from the contractor. The over payment shall include any excess payment made to the due to any omission or negligence.
- XVII) The Cantt Board is not bound to purchase the articles given in the quotation notice but the contractor shall be bound to supply any over the above quantity mentioned at the rates mentioned above.
- XVIII) No duplicate/fake goods other than as per specification will be accepted.
- XIX) In case of violation of any terms and conditions the Cantt Board Amritsar Cantt reserves the right to black list the agencies or and debar the agencies from submission of quotations of the cantonment Board, Amritsar Cantt in future as it may deem proper.
- XX) The rates should be quoted inclusive of all taxes with freight charges.
- XXI) The bidder shall give their full address in the quotation & will keep the Cantonment Board Office informed about the change of their address if any.
- XXII) Submission of a quotation implies that the bidder has read this notice and is aware of the details of the items.
- XXIII) The bidder shall not transfer/sublet the contract to any other contractor/person.
- XXIV) If the date of opening of quotations is declared as holiday then quotations will be received and opened on the next working day at the same time.
- XXV) The bidder shall supply a sample of the product offered by him/her and the same shall have to be approved by the competent authority. The sample will be returned to the bidder in case the sample is rejected by the competent authority.




